
Special moments call for special celebrations, they also offer an opportunity to look back, re-evaluate, see what is working well, what is not and why and work on improving upon them going forward.

The Canada India House will be a first anywhere in the world and will be used by future generations, all big things start with a thought, right?

You will get permanent recognition on the Walls of the House, on rooms and museums, lifetime invites to all the events and activities at the Canada India House, Special Donor Recognition events and Get-togethers every year and many other benefits.

I don't have much time to get into all the details here tonight, but you get it, right? Can I see a few pledges tonight to take this project forward?

I have always believed in, always worked towards and always said that we, all individuals and organizations working on the Canada India Corridor should not only work together, but also need to be seen working together. Can we do it with the Canada India House Project, funded by Indo-Canadians together?

Lastly, a Special Thank you to the best diplomatic team we have in Canada today, High Commissioner Ajay Bisaria, Deputy High Commissioner Anshuman Gaur, Consul General of India to Toronto Apoorva Srivastava. They have all been rock stars and a solid support to us all. It will be heart breaking to see all of them soon depart to their next postings. Consul General of India to Vancouver Mr. Manish is away and could not join us today.

In the end, let us celebrate today but also remember that a 10,000 year old civilization is only 75 years young as a modern nation in it's present geographical form. Much has been achieved in 75 years but a lot more has to be done before everyone can enjoy the fruits of our progress and success. Let us look at it as Glass Half Full and do what we can to make things better.

She has received many awards including the Order of Canada, the Ordre du Mérite from France, Commander of the Ordre de la Couronne de la Belgique, the Distinguished





Pankaj believes that education is the key to equality and prosperity. That is why most of his philanthropic activities have been around education.



He has participated in Trade Missions to India led by the Government of Canada (2017 & 2018), Government of Ontario (2015 & 2019), and Government of British


